Representatives from supervisory authorities will also be asked to present their strategic priorities and capacity-building demands during the roundtable session.

To assist supervisors in preparing for the roundtable, we have included the following questions for prior reflection:

- 1. Supervisory priorities - strategic view: What are the top three supervisory priorities for your authority in the next three years?*
- 2. Capacity building needs – internal development focus: What are the top three capacity building priorities for your authority?*
- 3 Training formats - preferred training methods: Does your authority prefer virtual or physical trainings when travel resumes or does this vary depending on type of activity?*

We encourage you to register, as the event will provide an opportunity not only to hear first-hand about the strategic priorities and plans of A2ii, IAIS and FSI but also an opportunity to discuss your priorities with peers and influence regional capacity building plans.
